Dear Mr. Cotter:

I write to respond to your Freedom of Information request dated and received in my office on December 19, 2013, in which you requested:

“I am looking to see if the complete bid packets are available for the 1mca1324 RFP.

Bidder supplied information.”

Information responsive to your request is available and attached. These are public documents numbering 140 pages.

Portions of these documents have been redacted pursuant to the following section(s) of the Act:

- 140/7(1)(b) that exempts from disclosure “Private information, unless disclosure is required by another provision of this Act, a State or federal law or a court order.” This includes social security numbers, FEINs and Illinois Secretary of State Identification numbers.
- 140/7(1)(c) that exempts from disclosure “Personal information contained within public records, the disclosure of which, if disclosed, would constitute a clearly unwarranted invasion of personal privacy, unless the disclosure is consented to in writing by the individual subjects of the information.” This includes home addresses, phone numbers, and personal financial information.
- 140/7(1)(g) that exempts from disclosure “Trade secrets and commercial or financial information obtained from a person or business where the trade secrets or commercial or financial information are furnished under a claim that they are proprietary, privileged or confidential, and that or where disclosure of the trade secrets or commercial or financial information would cause competitive harm to the person or business...” This information, which was provided under a claim that it is confidential, a trade secret or proprietary, would cause competitive harm if released.
