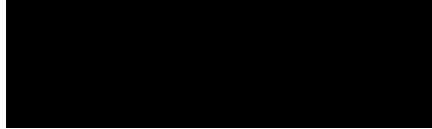

Dear Mr. Thomas:

I am responding to your request dated February 12, under the Illinois Freedom of Information Act in which you request:

- “1. The salary, benefits, and any other compensation paid to Mr. James Kilgore in the last 24 months. Please include insurance, pension, commuter, and any other benefits paid for by state university funds.
2. The employment title or titles of Mr. James Kilgore and the start date of his employment and the campus location(s) where he works.
3. The names and titles of any persons (excluding students enrolled, but including paid employees who may also be students) the Mr. James Kilgore now supervises in an employment capacity.
4. Any known or suspected assumed (fake) names in use, used, or otherwise used by Mr. James Kilgore for purposes of employment. Please note Mr. James Kilgore is a convicted murderer and has a long history of fake name usage to avoid criminal arrest in the United States as described in this news report.

Information responsive to your request is available and attached. These are public documents numbering 3 pages.

Portions of these documents have been redacted pursuant to the following section(s) of the Act:

- 140/7(1)(b) that exempts from disclosure “Private information, unless disclosure is required by another provision of this Act, a State or federal law or a court order.” This includes university identification numbers as well as personal financial information.
- 140/7(1)(c) that exempts from disclosure “Personal information contained within public records, the disclosure of which, if disclosed, would constitute a clearly unwarranted invasion of personal privacy, unless the disclosure is consented to in writing by the individual subjects of the information.” This includes personal financial information.
