Dear Ms. Imhoff:

I write to respond to your Freedom of Information request of January 22, 2014, and received in my office on that date, in which you requested the following information:

“... water well records in an effort to identify on-site and off-site wells within a 1000 ft radius (for private wells) and 2500 ft radius (for community wells), 3 Waukegan Road, Glenview, IL. Site is in **SW Fractional Quarter of Section 7, Township 41 N, Range 13E** and **SW Fractional Quarter of Section 7, Township 41N and Range 13E. ...”**

Information responsive to your request is available and attached. These are public documents numbering 98 pages.

Portions of these documents have been redacted pursuant to the following section(s) of the Act:

- 140/7(1)(b) that exempts from disclosure “Private information, unless disclosure is required by another provision of this Act, a State or federal law or a court order.” This includes cell phone numbers and license numbers.

In a January 24 email from Mr. William Saylor of the Illinois State Water Survey, and by a voicemail left on that date by my office, you were given the opportunity to provide clarification regarding your request, and you were advised that requests for this type of data are commonly received and responded to by the Survey office without a FOIA request being filed. However, as requested, we are processing this request under FOIA.

As we do not have clarification regarding the documents sought, we are providing the usual and customary documents as would be provided by ISWS to a non-FOIA request for this data.

Should you wish to inspect or receive a physical copy of these documents, please call Melanie Kuehn at the phone number below and she will provide you with all necessary details.

Per 5ILCS 140/9.5(b), you have a right, under the law, to seek a review of your status as a commercial requestor by the Public Access Counselor in the Office of the Attorney General.
