Dear Mr. Cohen:

I write to confirm receipt of your Freedom of Information request of December 10, in which you requested the following information:

- c. Most recent income (ideally 12-13 fiscal year) associated with Sports Camps for any employee, if available.

2. Pursuant to applicable authority, I am writing to request a copy of any contract or written agreement in force (i.e., signed, fully executed) between the University's Department of Athletics (or its affiliates) and State Farm for the naming rights to State Farm Center that sets forth the payments to the University's Department of Athletics (or its affiliates) in consideration for the grant of naming rights.

3. Pursuant to applicable authority, I am writing to request a copy of the most current athletic facility master plan, including the most current athletic facility plan for individual athletic facility projects (e.g., new practice facility).

4. Pursuant to applicable authority, I am writing to request a copy of any contract or written agreement in force (i.e., signed, fully executed, including amendments thereto) between the University's Department of Athletics and other Universities' Departments of Athletics for nonconference Men's and Women's basketball games scheduled to be played during the 2013-2014 season and future years."

Information responsive to your request is available and attached. These are public documents numbering 462 pages. Please note that your request for "...the most current athletic facility master plan..." is still in draft form and is being denied at this point. Feel free to request that document at a later date. Also, there are eight (8) Notices of Appointments that are not yet available for 2014. They should be available in the next few weeks and our office will provide those once they are made available to us.

Portions of these documents have been redacted pursuant to the following section(s) of the Act:

- 140/7(1)(b) that exempts from disclosure “Private information, unless disclosure is required by another provision of this Act, a State or federal law or a court order.” This includes home addresses and university identification numbers.

Should you wish to inspect or receive a physical copy of these documents, please call Melanie Kuehn at the phone number below and she will provide you with all necessary details.

You have a right, under the law, to seek a review of this response by the Public Access Counselor (PAC) in the Office of the Attorney General. You also have the right to seek judicial review under section 11 of this Act.
