I write to respond to your Freedom of Information request dated and received in my office on April 30, 2014, in which you requested:

“...a copy of documents containing the following information be provided to me:

University of Illinois at Urbana-Champaign RFP 1APG1405: Relocation Services

I would like a copy of the response from the vendor it was awarded to:

Vendor: Federal Warehouse Company, East Peoria, IL

Amount: An estimated \$900,000

This was awarded on April 25, 2014 by the University of Illinois.”

Information responsive to your request is available and attached. These are public documents numbering 199 pages.

Portions of these documents have been redacted pursuant to the following section(s) of the Act:

- 140/7(1)(b) that exempts from disclosure “Private information, unless disclosure is required by another provision of this Act, a State or federal law or a court order.” This includes home addresses, telephone numbers, and other unique identifiers.
- 140/7(1)(g) that exempts from disclosure “Trade secrets and commercial or financial information obtained from a person or business where the trade secrets or commercial or financial information are furnished under a claim that they are proprietary, privileged or confidential, and that or where disclosure of the trade secrets or commercial or financial information would cause competitive harm to the person or business...” Pursuant to this exemption, certain financial information was redacted. Release of this information would cause competitive harm to the vendor and, thus, was redacted from the records.
