2. Any and all procurement records, including bid solicitation documents, bid solicitation responses, contracts, contract amendments, contract extensions, and contract modifications, between the University of Illinois Chicago, including Rockford and Peoria, and Maximus since January 1, 2013.
3. Any and all procurement records, including bid solicitation documents, bid solicitation responses, contracts, contract amendments, contract extensions, and contract modifications, between the University of Illinois Chicago, including Rockford and Peoria, and Appleone since January 1, 2013.
4. Any and all procurement records, including bid solicitation documents, bid solicitation responses, contracts, contract amendments, contract extensions, and contract modifications, between the University of Illinois Chicago, including Rockford and Peoria, and Staffing Team since January 1, 2013.”

Information responsive to your request is available and attached. These are public documents numbering 87 pages. No records could be located to the portion of your request seeking records relating to Appleone. Please note, the University also had no records responsive to the portion of your request seeking records related to Maximus; however, we do have records related to Maxim Staffing.
