Dear Mr. Mercer:

I am responding to your request dated August 11, under the Illinois Freedom of Information Act in which you request:

“emails to or from Urbana-Champaign campus Phyllis Wise, university attorneys Tom Bearrows and Steve Veazie, Director of American Indian Studies Robert Warrior and Associated Provost for Human Resources Elyne G. Cole between July 22, 2014, and Aug. 5, 2014, that reference Steve Salaita or are correspondence with Salaita. I would also like to receive copies of any written correspondence mailed to Salaita from any of those people during that period.”

Information responsive to your request is available and attached. These are public documents numbering 204 pages.

Portions of these documents have been redacted and other documents have been withheld pursuant to the following section(s) of the Act:

- 140/7(1)(a) that exempts from disclosure “Information specifically prohibited from disclosure by federal or State law or rules and regulations implementing adopted under federal or State law.” Under this exemption, information discussed with an attorney that is required to remain confidential under state law, including, without limitation, the Illinois Rules of Professional Conduct were withheld from the responsive documents. Also under this exemption, student names were redacted pursuant to the Family Educational Rights and Privacy Act (FERPA) (20 U.S.C. §1232g), which protects the privacy of student education records and prohibits the release of any information from a student’s education record without the consent of the eligible student or parent of the student.
- 140/7(1)(b) that exempts from disclosure “Private information, unless disclosure is required by another provision of this Act, a State or federal law or a court order.” This includes cell phone numbers and personal email addresses.
- 140/7(1)(c) that exempts from disclosure “Personal information contained within public records, the disclosure of which, if disclosed, would constitute a clearly unwarranted invasion of personal privacy, unless the disclosure is consented to in writing by the individual subjects of the information.” This includes the personal information and

identity of private citizens who contacted University staff to express opinions as well as other personal information, such as vacation plans and housing information.

- 140/7(1)(f) exempts “preliminary drafts, notes, recommendations, memoranda and other records in which opinions are expressed, or policies or actions are formulated, except that a specific record or relevant portion of a record shall not be exempt when the record is publicly cited and identified by the head of the public body.” The responsive documents contain preliminary discussions and expressions of opinion regarding possible policies and actions of the University.
- 140/7(1)(m) exempts “communications between a public body and an attorney or auditor representing the public body that would not be subject to discovery in litigation, and materials prepared or compiled by or for a public body in anticipation of a criminal, civil or administrative proceeding upon the request of an attorney advising the public body, and materials prepared or compiled with respect to internal audits of public bodies.” A portion of your request includes communication between a public body and an attorney representing the public body for the purpose of obtaining legal advice and would not be subject to discovery in litigation.

You have a right, under the law, to seek a review of this response by the Public Access Counselor (PAC) in the Office of the Attorney General. You also have the right to seek judicial review under section 11 of this Act.
