Dear Mr. Cohen:

I write to confirm receipt of your Freedom of Information request of July 18, in which you requested the following information:

“1. Pursuant to applicable authority, I am writing to request a copy of any contract or written agreement in force (i.e., signed, fully executed) between the University’s Department of Athletics (or its affiliates) and third parties regarding all of the following categories of subject matter:

a. The current agreement I have previously received with Nike is set to expire in 2016. If there is an updated contract or amendment, please send, otherwise no need to resend.

b. The current Concessions Contract I have with Sodexo Expired.

c. The current agreement I have previously received with Coke is set to expire in 2015. If there is an updated contract or amendment, please send, otherwise no need to resend.

d. The current Ticketing Contract I have with Paciolan may have auto-renewed according to its terms; provided however, if new terms have been memorialized in a new contract document, then I request that new document (such as an amendment or new contract). If a new agreement altogether with a different vendor has been entered into, than I request that new document.

e. The current agreement I have previously received with CLC is set to expire in 2016. If there is an updated contract or amendment, please send, otherwise no need to resend.

f. Multi-media rights (through firms such as IMG, Learfield, Nelligan, etc).

g. Outsourced Ticketing contract with Collegiate Consulting.

h. Video management (through firms such as XOS)”

Information responsive to your request is available and attached. These are public documents numbering 185 pages. No contracts exist between the university and Sodexo or

with any video management services. Also, you have the most current contracts between the university and Nike, Coke, CLC, and Paciolan.

You have a right, under the law, to seek a review of this response by the Public Access Counselor (PAC) in the Office of the Attorney General. The PAC may be reached by phone at 217-782-1396, by email to publicaccess@atg.state.il.us, or by postal mail at the Public Access Bureau, 500 S. 2nd Street, Springfield, Illinois 62706. You also have the right to seek judicial review under section 11 of this Act.
