I write to respond to your Freedom of Information request dated and received in my office on September 30, 2014, in which you requested:

“Re Procurement Documents:

Armory – Classroom Repairs, BAU10084 and QBS #PSSU10084

1. Professional Service Consultant Submittal – Tilton, Kelly & Bell Architects
2. Copy of the Contract/Professional Services Agreement to include all attachments, between the University and Tilton, Kelly & Bell Architects and the University and Bishop Brothers.
3. Copy of all information submitted by Tilton, Kelly & Bell and Bishop Brothers required by the University upon award of the contract, including but not limited to, insurance bonds, general and professional liability insurance, licenses, information on consultants, etc.”

Information responsive to your request is available and attached. These are public documents numbering 218 pages.

Portions of these documents have been redacted pursuant to the following section(s) of the Act:

- 140/7(1)(b) that exempts from disclosure “Private information, unless disclosure is required by another provision of this Act, a State or federal law or a court order.” This includes FEINs, state license numbers and other unique identifiers.
- 140/7(1)(g) that exempts from disclosure “Trade secrets and commercial or financial information obtained from a person or business where the trade secrets or commercial or financial information are furnished under a claim that they are proprietary, privileged or confidential, and that or where disclosure of the trade secrets or commercial or financial information would cause competitive harm to the person or business...” This includes certificate of liability insurance policy information.
