Dear Mr. Stillwell:

I write to respond to your Freedom of Information request dated and received in my office on November 21, 2014, in which you requested:

“We would like to have details about the number of registered bikes on UIUC campus in the past 3 years, with information that includes date of registration and other pertinent information.”

Information responsive to your request is available at the following link:

[REDACTED] These are public documents numbering 107 pages.

Portions of these documents have been redacted pursuant to the following section(s) of the Act:

- 140/7(1)(a) that exempts from disclosure “Information specifically prohibited from disclosure by federal or State law or rules and regulations implementing adopted under federal or State law.” The Family Educational Rights and Privacy Act (FERPA) (20 U.S.C. §1232g) protects the privacy of student education records and prohibits the release of any information from a student’s education record without the consent of the eligible student. In this case, the names of students were redacted from the responsive record.
- 140/7(1)(b) that exempts from disclosure “Private information, unless disclosure is required by another provision of this Act, a State or federal law or a court order.” This includes personal email addresses, serial numbers and other unique identifiers.
- 140/7(1)(c) that exempts from disclosure “Personal information contained within public records, the disclosure of which, if disclosed, would constitute a clearly unwarranted invasion of personal privacy, unless the disclosure is consented to in writing by the individual subjects of the information.” This includes the names of private citizens and students.
