2. Pursuant to applicable authority, I am writing to request a copy of the 2013-2014 NCAA Annual Financial Report provided to the NCAA.

3. Pursuant to applicable authority, I am writing to request a copy of the 2013-2014 Audited Financial Report (Agreed-Upon Procedures)

4. Pursuant to applicable authority, I am writing to request a copy of any contract or written agreement in force (i.e. signed, fully executed, including amendments thereto) between the University’s Department of Athletics and other Universities’ Departments of Athletics for non-conference Men’s and Women’s basketball games scheduled to be played during the 2014-2015 season and future years.”

Information responsive to your request is available and attached. These are public documents numbering 91 pages. Please note, there are no responsive documents to point #3 of your request. The NCAA requires the Audited Financial Report (Agreed-Upon Procedures) to be filed every three years. This was completed for FY 2012, and the next report will not be filed until FY 2015 is complete.
