Dear Member of the Illinois Congressional Delegation:

We write to urge you to ensure that the emergency coronavirus legislation currently being drafted in Congress includes essential relief for Illinois' public institutions and students.

As we work to protect the health, livelihoods and educations of our students, faculty and staff, the University of Illinois System is facing significant costs and unprecedented burdens. Those immediate costs include an estimated \$35 million in refunds for housing and dining payments to U of I System students who are going to continue their studies from home; ongoing expenses associated with transitioning to online education and telework; and millions of dollars in lost revenues from cancelled events. In addition, we estimate that the U of I System will expend approximately \$96 million complying with the paid FMLA expansion in H.R. 6201, the Families First Coronavirus Response Act (FFCRA), and another \$54 million complying with the paid sick leave requirements in that legislation.

Accordingly, we respectfully ask that you advocate for the following relief:

- Emergency funding both to financially stabilize universities as they respond to the COVID-19 pandemic, and to directly support students. While we are pleased that the draft bill released by Senate Majority Leader McConnell includes an Education Stabilization Fund, it only provides \$6 billion for higher education institutions and students—far less than the tens of billions of dollars that are urgently needed—and includes a potentially cumbersome model for disbursing the funds.
- Making public universities eligible for the refundable tax credits that the FFCRA
 provided for private employers to offset costs associated with paid sick leave/FMLA
 expansion.
- Assistance for academic health centers such as UI Health, including direct payments to
 hospitals to support care delivery, funds for preparedness support and emergency
 expenses, Medicaid and Medicare extenders including a delay in disproportionate share
 hospital (DSH) payments, and Medicaid/Medicare waiver flexibility.
- University access to capital through low- or no-interest loans.
- Regulatory flexibility and resources on research issues, as outlined in this letter.
